The undersigned grants the O'ahu Hawaiian Canoe Racing Association and its representatives permission to telecast, show and / or print and publish any and all pictures taken of me (the undersigned) or the crew collectively in conjunction with the Hawaiian Airlines Moloka'i Hoe Race, the undersigned releases the O'ahu Hawaiian Canoe Racing Association and its representatives all right to publication and / or other use of aforementioned pictures for their brochures, promotional and / or other printed material without remuneration.

We agree to the following:

1. We have read and understood the 2017 Hawaiian Airlines Moloka'i Hoe Race Rules.
2. We attest that all information submitted both electronically and written are accurate to our knowledge.
3. We attest that we have no medical condition, ailment or disability (physical/mental), which would affect our ability to paddle competitively, be water safe, and survive any risks or hazards arising out of competition.
4. We have read and understand the announcement regarding FISHING while on Moloka'i.
5. We understand that all crew members in the canoe must have their UNIFORMS on the START & FINISH of the race.
6. We understand that ALL paddlers will have to be WRISTBANDED to be legal and eligible during the race.
7. We understand that the use of TIRES at Haleolono is not acceptable and fines will be assessed if used.
8. We understand that the crew is responsible for all of our TRASH on Moloka'i, on the water and in Waikiki.
9. We agree to use caution while entering Waikiki as there are swimmers, snorkelers and divers in the area.
10. We agree to inform our boat captain(s) that creating a WAKE for our canoe to surf on is illegal and will result in a time penalty of 30 minutes.
11. We understand that all race paperwork & supporting documents need to be turned in NO later than Saturday, October 6, 2017 11:00am at Paddler's Inn on Moloka'i. Fines up to \$1,000.00 may be assessed.
12. We understand that the Coaches / Boat Captains meeting is on Saturday at 2:00pm at Paddler's Inn and we will be in attendance along with my boat captain or designee.
13. We understand that we are here to compete in our fullest capacity and within the highest spirit of GOOD SPORTSMANSHIP!!!
